



Mayor and City Council:

In accordance with Texas Civil Statutes, I respectfully present the 2018 – 2019 Fiscal Year Budget for the City of Canadian as approved by the Canadian City Council on September 17, 2018. The budget beginning October 1, 2018, and ending September 30, 2019, provides for total revenues of \$ 3,930,931 and total expenditures of \$ 3,765,210. The 2018 certified net taxable value of property in the City of Canadian is \$135,822,470. The *ad valorem* tax rate as established by the Council for FY 2018-2019 is \$0.667392 per \$100 of assessed valuation. Sales Tax revenue is predicted to increase slightly during this fiscal year.

Major projects that were completed by the City of Canadian during Fiscal Year 2017-2018 included reconstruction of the wastewater treatment plant project. The initial phase of the U.S. Highway 60/83 Reconstruction Project began during the latter part of the Fiscal Year. The focus of the FY 2018-2019 budget year will be infrastructure maintenance and long – term infrastructure replacement planning. Minor capital expenditures have been allotted for equipment and maintenance upgrades for Maintenance, Water and Sewer, Transfer Station, and Golf Departments. The budget also includes a two percent (2%) cost – of – living increase for all full – time employees.

Hemphill County Commissioner's Court has provided financial relief to the City by assuming all funding for the Canadian Volunteer Fire Department.

A water rate study is currently underway, which should determine an appropriate rate to finance the earlier – mentioned infrastructure replacement projects. Although increased trash - collection rates improved the financial condition of the Sanitation Fund, further rate analysis should continue in an effort to generate additional revenue.

The FY 2018-2019 Annual Budget provides for all City of Canadian services at existing or improved levels. Staff is dedicated to operating within the limits outlined in the FY 2018 – 19 budget. It is our policy to provide services at optimum levels.





ORDINANCE No. 700

AN ORDINANCE SETTING THE TAX RATE AND LEVYING A TAX UPON ALL PROPERTY SUBJECT TO TAXATION WITHIN THE CITY OF CANADIAN, TEXAS, FOR THE YEAR 2018; PROVIDING FOR A DISCOUNT FOR EARLY PAYMENT OF SUCH TAXES; ASSESSING PENALTY AND INTEREST FOR THE NON-PAYMENT OF SUCH TAXES WITHIN THE TIME SET; AND PROVIDING FOR THE COLLECTION OF SUCH TAXES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CANADIAN, TEXAS:

SECTION I

That there shall be and the same is hereby levied and shall be assessed and collected for the year 2018, an ad valorem tax of \$0.667392 on each One Hundred Dollars (\$100.00) worth of property at One Hundred Percent (100%) assessed valuation located within the present City Limits of the City of Canadian and subject to taxation by law, which said taxes when collected shall be appropriated as follows:

For Operations and Maintenance - \$0.600361
For Interest and Sinking - \$0.067031

SECTION II

That a discount of three percent (3%) be allowed on the above levied taxes that are paid during the month of October, 2018, that there be a discount of two percent (2%) allowed on the above levied taxes that are paid in the month of November, 2018, and that there be a discount of one percent (1%) allowed on the above levied taxes that are paid in the month of December, 2018.


SECTION III

That all ad valorem taxes shall be paid before February 1, 2019, and taxes not paid before that date shall be delinquent and all persons or property owners failing to pay taxes owed before the delinquent date shall be charged interest at a rate of one percent (1%) for each month or portion of a month the tax remains unpaid; and in addition to interest, shall be charged a penalty of six percent (6%) of the principal amount of the tax for the first calendar month it is delinquent, plus one percent (1%) for each additional month or portion of a month the tax remains unpaid prior to July 1, 2019. However, a tax delinquent on July 1, 2019, incurs a total penalty of twelve percent (12%) of the amount of the delinquent tax without regard to the number of months the tax has been delinquent.

SECTION IV


That the Tax Assessor and Collector of the City of Canadian is hereby directed to assess, extend, and enter upon the tax rolls of the City of Canadian, Texas, for the current taxable year, the amounts and rates herein levied and to keep a current account of same, and when so collected, the same is to be deposited in the depository of the City of Canadian.
